

# Finna API Terms of Use

No registration is required to use the open application programming interface (API) of the [Finna.fi](#) service. The National Library's Library Network Services may, however, choose to introduce registrations if the functions of the interface must be restricted, e.g., to avoid excessive server load.

The metadata provided through the interface is licenced under the Creative Commons [CC0 1.0 Universal Public Domain Dedication](#).

This licence does not pertain to the resources linked to the metadata, such as images relating to the entries. Such linked resources are included in the fields titled *urls*, *onlineUrls* and *images*. Use of the linked resources must comply with the terms of use indicated with the resource or in the fields *imageRights* and *accessRestrictions*. If no terms of use are indicated, permission to use the resource must be requested from the organisation providing it.

Due to third-party copyrights the metadata in the interface do not represent the total metadata offered in the [Finna.fi](#) service. The CC0 licence does not pertain to metadata which are not provided through the API.

Users of the API are invited to read the CC0 deed carefully and pay particular attention to the following: "In no way are the patent or trademark rights of any person affected by the CC0, nor are the rights that other persons may have in the work or in how the work is used, such as publicity and privacy rights."

The National Library's Library Network Services is not responsible for the accuracy of the metadata. Any corrections to metadata should be addressed to the organisations that produced the metadata. The National Library's Library Network Services is not the rights holder for the metadata or the linked resources. The organisations providing the metadata and linked resources to the [Finna.fi](#) service are responsible for the right to provide the data and resources under the terms of use described above. ## API use recommendations

The metadata provided through the interface are licensed under the Creative Commons [CC0 1.0 Universal Public Domain Dedication](#) and are freely available. It is recommended, however, that the source of the data, i.e. the [Finna.fi](#) service, be mentioned when using the data, as well as the organisations which produced the data.

The metadata for the library material released through the interface may include bibliographic information from the OCLC. Users of the library metadata are requested to also indicate the OCLC as one of the producers of the metadata.
